Air Quality Operating Permit

for Caja Del Rio Landfill of Santa Fe (City of) Solid Waste

Santa Fe (City of) Solid Waste at 149 Wildlife Way; Santa Fe, NM 87506 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Caja Del Rio Landfill. The owner of this plant is Santa Fe (City of) Solid Waste. The exact location of the facility is at latitude 35 deg, 40 min, 22.1043 sec and longitude -106 deg, 4 min, 18.1717 sec, Datum: NAD27. To aid in locating this facility, the approximate location is 3.3 miles NW of Santa Fe in Santa Fe County, New Mexico. This application file has been assigned an Operating Permit Number P185L-R3M1 and TEMPO Agency Interest ID No. 1484.

Previously, the plant received an air quality construction permit, if one was required, and is in operation or able to operate. The main purpose of the plant is to accept Municipal Solid Waste.

This operating permit application is for a permit modification. Per 20.2.70.400 NMAC. There are no physical changes to the facility. This modification includes 1) adding the Godwin water pump engine (Unit Godwin) in the list of regulated sources (currently listed as an insignificant source) since it is subject to 40 CFR 63, Subpart ZZZZ; 2) updating the emissions from compost screening operations (Units TROM and TROM-eng) for an operation of 800 hours/year and the maximum rating (70 hp) for consistency within the application calculations (prior permit's emissions had conservative, but varying, operating hours for the various backup pages and utilized a lower hp for recommended, not maximum, hp); 3) updating the flare stack attributes; 4) updating the maximum uncontrolled and allowable emissions based on the maximum engine horsepower (HP) rating; and removed TSP/PM emission limits since the repeal of the New Mexico TSP Rule. Applicability to NSPS WWW was replaced by XXX which is now effective for this facility.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance status.

No modeling was required for this action.

The NMED has made a preliminary determination that this plant will comply with the requirements of New Mexico Administrative Code 20.2.61, 20.2.70, 20.2.71, 20.2.73, 20.2.77, 20.2.82, the New Mexico Air Quality Control Act, 40 CFR 50, 40 CFR 60 Subparts A and XXX, 40 CFR 63 Subparts A and AAAA, and 40 CFR 82. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before October 31, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P185L-R3M1 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
