Air Quality Operating Permit  
for Carracas CDP Compressor Station of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its **Carracas CDP Compressor Station**. The owner of this plant is Harvest Four Corners, LLC. The exact location of the facility is at latitude and longitude decimal degrees: 36.938733, -107.354067 Datum: NAD83. To aid in locating this facility, the approximate location is 21 miles NE of Blanco in Rio Arriba County, NM. This application file has been assigned an **Operating Permit Number P168R4** and TEMPO Agency Interest ID No. 1009.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress and dehydrate natural gas for pipeline transport.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporation of changes made in NSR permit 0968-M5R7 through 0968-M5R11. The facility is/has removed four (4) RICE engines, four (4) TEG dehydrator, four (4) reboilers associated with dehydrators and two (2) flares associated with the dehydrators.

The emissions, as established in NSR Permit 0968-M5R7 through 0968-M5R11 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P168-R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO<sub>x</sub>) at 162 tpy (-81); Carbon Monoxide (CO) at 36 tpy (-24); Volatile Organic Compounds (VOC) at 52 tpy (-24); Sulfur Dioxide (SO<sub>2</sub>) at 0 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 4 tpy (-2), and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 4 tpy (-2); and greenhouse gas (CO<sub>2</sub>e) 110,498 tpy.

The estimated maximum air pollutant emissions to the atmosphere, from this facility after the requested operating permit is issued, are as follows. The facility is a major, >100,000 tpy CO<sub>2</sub>e, major source of greenhouse gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, and 77; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ (Potentially), OOOO (Potentially), OOOOa (Potentially); 40 CFR 63 Subparts A, HH, ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before July 30, 2021.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
