Air Quality Operating Permit
for Lordsburg Generating Station of Public Service Company of New Mexico (PNM)

Public Service Company of New Mexico (PNM) at 2401 Aztec Rd NE, MS Z100; Albuquerque, NM 87107 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Lordsburg Generating Station. The owner of this plant is Public Service Company of New Mexico (PNM). The exact location of the facility is at latitude and longitude decimal degrees: 32.350278, -108.696944 Datum: NAD83. To aid in locating this facility, the approximate location is on the northeast side of Lordsburg at 2 Power Plant Road in Hidalgo County, NM. This application file has been assigned an Operating Permit Number P214-R3 and Acid Rain Permit Number P214A-R4 and TEMPO Agency Interest ID No. 560.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to operate as an electrical power generating station. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action is a renewal for another 5-year term. There were no construction permit revisions since the previous operating permit renewal.

There are no changes to the existing air emission limits in this permitting action. The emissions are expressed in tons per year (tpy) as follows: Nitrogen Oxides (NO_x) at 245.0 tpy; Carbon Monoxide (CO) at 245.0 tpy; Volatile Organic Compounds (VOC) at 62.0 tpy; Sulfur Dioxide (SO₂) at 7.1 tpy; Particulate Matter 10 microns or less (PM₁₀) at 91.2 tpy; Particulate Matter 2.5 microns or less (PM_{2.5}) at 91.2 tpy; and greenhouse gas (CO_{2e}) at 364,207 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance. The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 77, and 84; 40 CFR 50; 40 CFR 60 Subparts A and GG; 40 CFR 72; 40 CFR 73; 40 CFR 75; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before August 21, 2021.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P214-R3 and Acid Rain Permit Number P214A-R4 by contacting James Nellesen at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
