## ATTACHMENT 1

### GENERAL FACILITY DISCRPTION

Cannon Air Force Base (CAFB) is currently an active military installation that houses the United States Air Force's 27<sup>th</sup> Special Operations Wing. Cannon Air Force Base is located in eastern New Mexico on approximately 4,320 acres of land owned by the federal government in Curry County, New Mexico. The site is located seven miles west of Clovis, fifteen miles north of Portales, New Mexico, and south of United States Highway 64/84. Based on World Grid System 1984 (WGS84) the Facility is located at a latitude of 34 degrees, 22 minutes, and 46.168 seconds and a longitude of 103 degrees, 18 minutes, and 30.459 seconds.

CAFB is situated in the Southern High Plains Physiographic Province of the Llano Estacado, a nearly flat east to southeast gently sloping plain. No major streams exist on or near CAFB. Running Water Draw and Frio Draw located approximately ten to 20 miles from the Base, respectively, are the nearest ephemeral streams in proximity to the facility.

Adjacent land is comprised of mixed use land utilized as residential, agricultural, and farmland to the north; agricultural and farmland to the east and south; and agricultural and open grassland to the west.

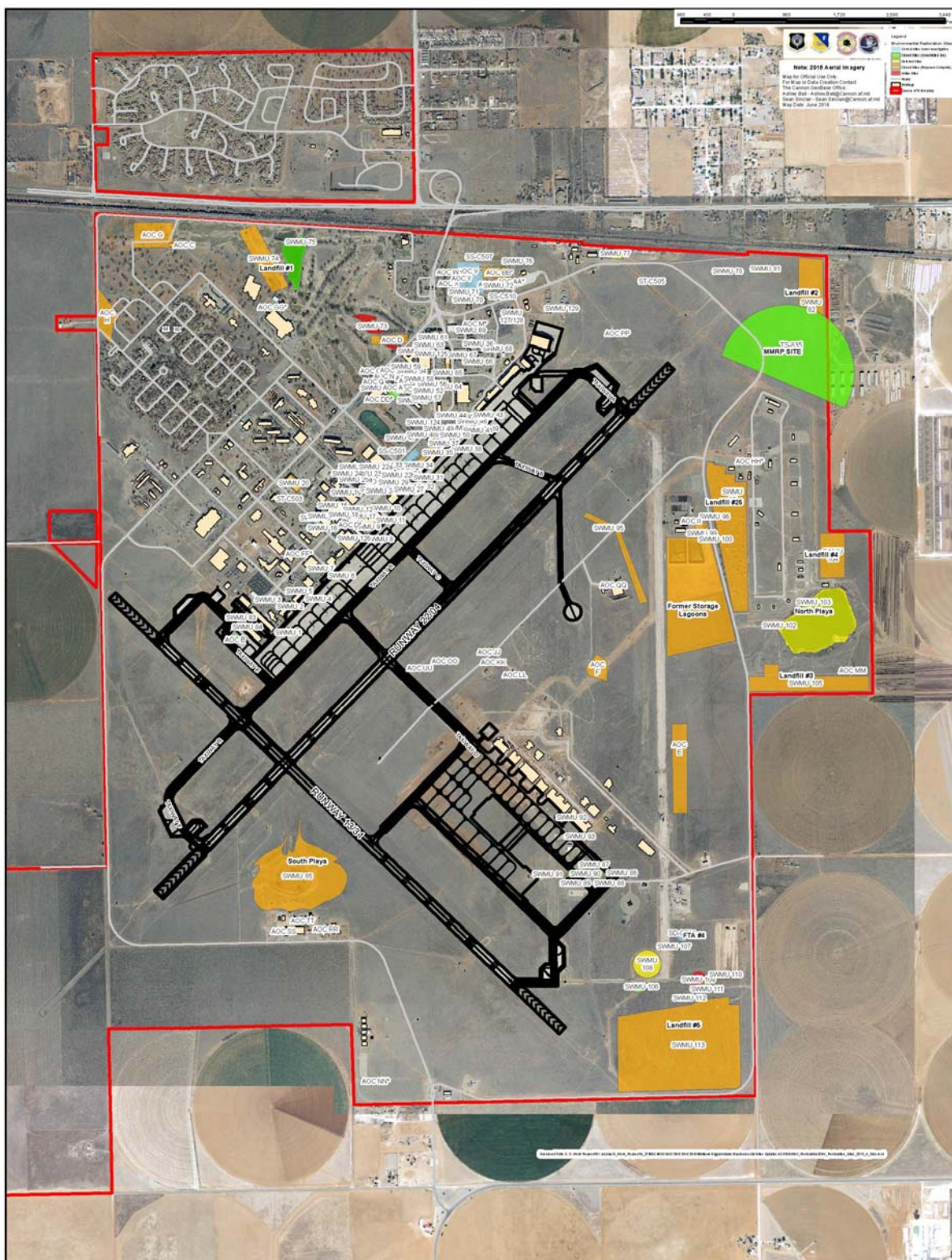
Development at CAFB dates to 1929 when the facility was a civilian passenger terminal (Portair Field). The Army Air Corps acquired control of the facility in 1942 and it was renamed Clovis Army Air Base. Clovis Army Air Base operated as an installation for aviation, bombing, and gunnery training until 1947 when the facility was deactivated. The base was reactivated as Clovis Air Force Base in 1951 and became a permanent military installation in 1957, when it was renamed Cannon Air Force Base. The 312<sup>th</sup> Tactical Fighter Wing (TFW) was the host unit at CAFB until 1959 when it was replaced by the 27<sup>th</sup> TFW. Continued use of the facility was evaluated by the Base Realignment and Closure (BRAC) Commission following the United States Secretary of Defense's recommendation to close the base in May 2005. Following review, the BRAC Commission recommended the installation remain open until the end of 2009 or until a new mission was found for the facility. The 27<sup>th</sup> Special Operations Wing (SOW) was activated at CAFB in 2006 under control of the Air Force Special Operations Command. The 27<sup>th</sup> SOW continues as the host unit at CAFB and conducts special operations missions including close air support, unmanned aerial vehicle operations, and non-standard aviation operations.

### PERMITTED ACTIVITIES

CAFB is a large quantity generator of hazardous waste and does not currently manage hazardous waste beyond 90-days. Storage of hazardous waste for less than 90 days is subject to the hazardous waste generator requirements of 20.4.1.300 NMAC (incorporating 40 CFR § 262) and does not require a permit. CAFB obtained a Resource Conservation and Recovery Act (RCRA) permit to store hazardous waste for periods greater than 90 days in a Container Storage Unit in 1989. The

Container Storage Unit was closed in August 2003; however, corrective action is required at solid waste management units (SWMUs) and areas of concern (AOCs) to comply with 20.4.1.500 NMAC (incorporating 40 CFR § 264.101). In October 2003, NMED issued a RCRA Corrective Action Permit to address sites where releases of hazardous waste or hazardous constituents were identified that require corrective action. SWMUs and AOCs requiring corrective action are listed in Permit Attachment 3, Corrective Action Status Tables, Table 1, List of SWMUs and AOCs Requiring Corrective Action. SWMUs and AOCs which have completed corrective action are listed on Permit Attachment 3, Table 2, List of SWMUs and AOCs with Corrective Action Complete with Controls Status and Table 3, List of SWMUs and AOCs with Corrective Action Complete without Controls Status.
