Air Quality Operating Permit

for Laguna Seca/ A-59 Compressor Station of Williams Four Corners LLC

Williams Four Corners LLC at 1755 Arroyo Drive; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Laguna Seca/ A-59 Compressor Station. The owner of this plant is Williams Four Corners LLC. The exact location of the facility at latitude 36 deg, 52 min, 48.47 sec and longitude -107 deg, 24 min, 8.89 sec, Datum: NAD83. This facility is located approximately 35 miles east of Aztec, New Mexico in Rio Arriba County. This application file has been assigned an Operating Permit Number P245-R2 and TEMPO Agency Interest ID No. 1011.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress and dehydrate natural gas for pipeline transmission.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the existing Title V permit and incorporation of administrative revisions to the permit since the last Title V permit was issued.

The estimated maximum air pollutant emissions to the atmosphere, from this facility after the requested operating permit is issued, are as follows. Parentheses note changes in emissions from previous operating permit – P245-R1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 122.3 tpy (-0.3); Carbon Monoxide (CO) at 97.0 tpy (-3.1); Volatile Organic Compounds (VOC) at 127.4 tpy (-3.8); Sulfur Dioxide (SO₂) at 0.3 tpy (not reported); Total Suspended Particulate Matter at 4.2 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 4.2 tpy (no change); Particulate Matter 2.5 microns or less (PM_{2.5}) at 4.2 tpy (no change); and greenhouse gas (CO₂e) at 207,822.9 tpy (not reported).

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ, OOOO and OOOOa; 40 CFR 63 Subparts A, HH and ZZZZ; 40 CFR 98; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before 6/21/2019.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P245-R2 by contacting Andrew Ahr at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
