

Legal Public Notice of Air Quality Permit Application. XTO Energy Inc, located at W4.6B.377, 22777 Springwoods Village Parkway, Houston TX 77389, submitted an application for an air quality permit to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for construct the Cowboy Central Delivery Point (CDP). The application number is 7877. The exact location of the facility will be at latitude 32 10 13.78 and longitude of -103 39 11.79 and it will be located about 17.6 miles southeast of Loving, Lea County, NM.

The Cowboy CDP consists of two primary functions, a Natural Gas Processing Plant and a Condensate Stabilization process to Crude Oil, Storage, and Loading facility that will produce, for sell, natural gas liquids (NGLs) from raw field gas and crude oil from liquid condensate.

Total air pollutant emissions to the atmosphere are estimated to be Nitrogen Oxides (NO_x) at 224 tons per year (tpy); Carbon Monoxide (CO) at 214 tpy; Volatile Organic Compounds (VOC) at 230 tpy; Sulfur Dioxide (SO₂) at 50.3 tpy; Total Suspended Particulate Matter (TSP) at 62 tpy, Particulate Matter 10 microns or less (PM₁₀) at 62 tpy, and Particulate Matter 2.5 microns or less (PM_{2.5}) at 54 tpy, and greenhouse gas (CO₂e) 560,750 tpy, and total hazardous air pollutants of 4 tpy. These emission estimates could change during the AQB's review of the application.

The AQB has conducted a preliminary review of the application and has determined that the application can be ruled administratively complete. Based on that review and the applicant's analysis of ambient air quality impacts, the applicants air dispersion modeling shows that the facility air emissions will meet the air quality standards for NO_x, CO, SO₂, TSP, PM₁₀, and PM_{2.5}. A full review will evaluate the estimated emission rates for the pollutants listed in this public notice, verify compliance with ambient air quality standards, and ensure that all air quality permit and performance standard requirements are met.

The permit application is available for review in electronic or hard copy form at the Air Quality Bureau Office, 525 Camino de los Marquez Suite 1, Santa Fe, New Mexico and at the Carlsbad NMED field office located at 406 N. Guadalupe, Suite C, Carlsbad, NM 88220.

All interested persons have 30 days from the date this notice is published to notify the AQB in writing of their interest in the permit application to trigger a subsequent 30-day review of the AQB's analysis. All individuals who submitted written comments by this deadline, will be notified when the AQB's analysis is available for review. If you did not submit written comments before this 30-day deadline, you will not be notified when the analysis is available but may still comment on it. Written comments on the analysis or permit application may be submitted to the AQB up until the permit is issued or denied.

Written comments need to include the facility name and application number, or a copy of this notice.
