

LEGAL NOTICE

Air Quality Operating Permit

for Trunk L Compressor Station of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Trunk L Compressor Station. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility is at latitude 36 deg, 38 min, 35.79 sec and longitude -107 deg, 21 min, 18.72 sec, Datum: NAD83. To aid in locating this facility, the approximate location is 36.5 miles east southeast of Bloomfield, New Mexico in Rio Arriba County. This application file has been assigned an Operating Permit Number P166-R4 and TEMPO Agency Interest ID No. 1037.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress and dehydrate pipeline quality natural gas for pipeline transmission using natural gas-fired reciprocating engines.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves 1527M5 – decrease Startup, Shutdown, Maintenance (SSM) emission limit from 34.2 tpy to 29.2 tpy VOC and increase Malfunction (M1) emission limit from 5.0 tpy to 10.0 VOC; One like kind replacement for existing engine Unit 04 added in NSR Permit 1527-M4-R7 on June 1, 2015; one like kind replacement for existing engine Unit 08 added in NSR Permit 1527-M4-R8 on June 1, 2015; one like kind replacement for existing engine Unit 7 added in NSR Permit 1527M5R1 on April 24, 2018; one like kind replacement for existing engine Unit 10 added in NSR Permit 1527M5R2 on June 27, 2018; and one like kind replacement for existing engine Unit 09 added in NSR Permit 1527M5R3 on October 12, 2018; and A change in the Ownership name change from Williams Four Corners LLC to Harvest Four Corners LLC in NSR Permit 1527-M5R5 issued October 25th, 2018.

The emissions, as established in NSR Permit 1527M5, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P166-R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 232.5 tpy (no change); Carbon Monoxide (CO) at 415.0 tpy (no change); Volatile Organic Compounds (VOC) at 375 tpy (no change); Sulfur Dioxide (SO₂) at 0.5 tpy (-1.3); Particulate Matter 10 microns or less (PM₁₀) at 5.4 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 5.4 tpy (no change); and greenhouse gas (CO_{2e}) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 74, 75, and 80; 40 CFR 50; 40 CFR 63 Subparts A and HH, 40 CFR 64; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before August 8, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P166-R4 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
